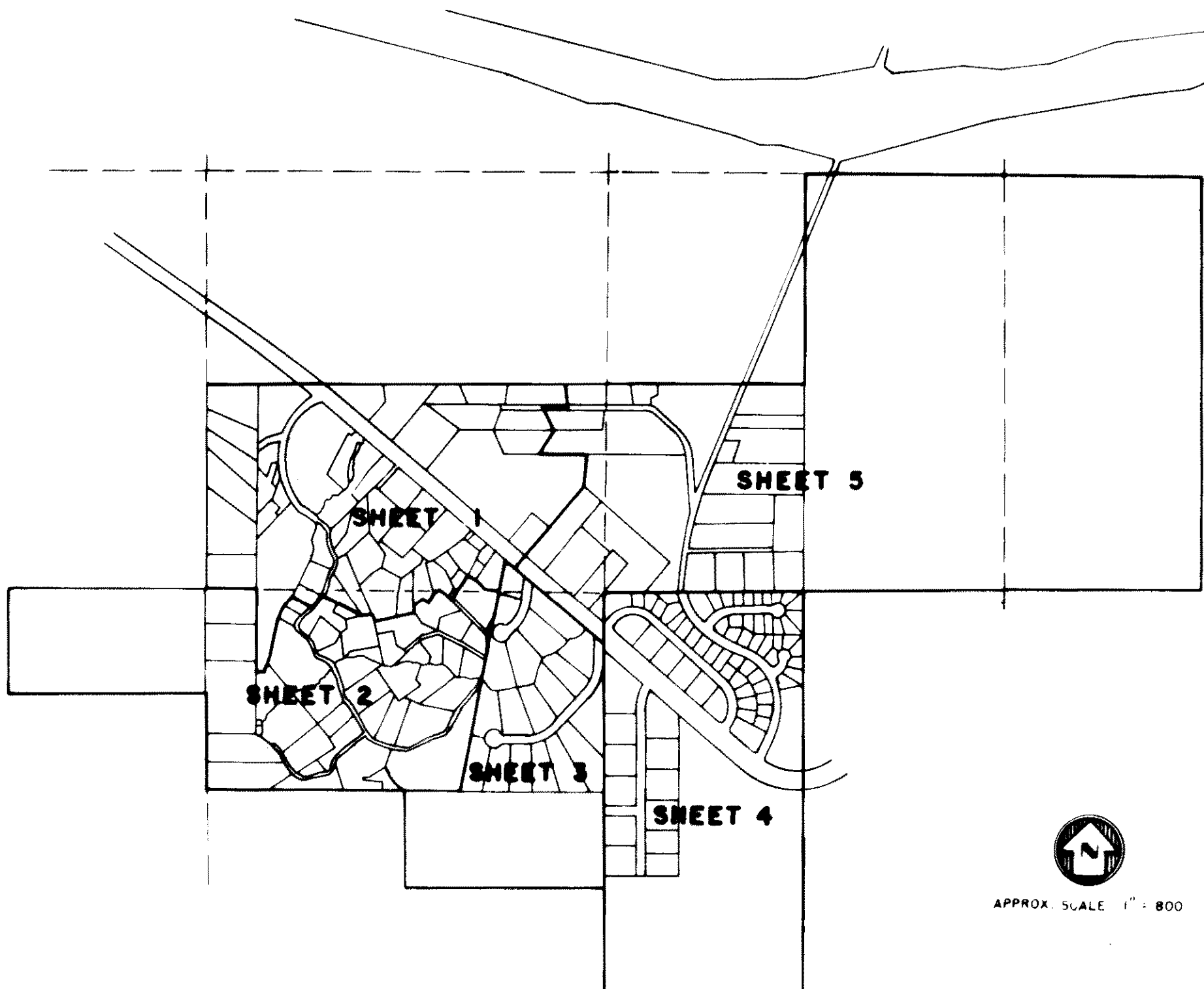


ASSESSMENT DIAGRAM INDEX MAP
